**The Parking Places on Roads and Waiting Restrictions  
(Cookstown) (Amendment) Order (Northern Ireland) 2019**

*Made* - - - - - *17th July 2019*

*Coming into operation* - *7th August 2019*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the road specified in Article 2(2).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department, in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objections or other representations have been received.

**Citation and commencement**

**1.** This Order may be cited as The Parking Places on Roads and Waiting Restrictions (Cookstown) (Amendment) Order (Northern Ireland) 2019 and shall come into operation on 7th August 2019.

**Amendments**

**2.—(1)** Schedule 1 to The Parking Places on Roads and Waiting Restrictions (Cookstown) Order (Northern Ireland) 2018<sup>(d)</sup> is amended in accordance with paragraphs (2) and (3).

(2) After item no. 64 add the following items—

- “65. Oldtown Street (west side) – from a point 84 metres north of its junction with Orritor Street for a distance of 5 metres in a northerly direction.
- 66. Oldtown Street (west side) – from a point 93 metres north of its junction with Orritor Street for a distance of 27 metres in a northerly direction.”

(3) Delete the following—

- (a) item nos. 22 and 27 relating to Oldtown Street; and
- (b) item no. 31 relating to Union Street.

#### **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends Schedule 1 to The Parking Places on Roads and Waiting Restrictions (Cookstown) Order (Northern Ireland) 2018 by—

- (a) removing a time restricted parking place on Oldtown Street and another on Union Street; and
- (b) splitting a parking place on Oldtown Street into two parking places separated by a gap at an entrance.
