The Monaghan Road, Armagh (Abandonment) Order (Northern Ireland) 2019

Made - - - - 9th September 2019

Coming into operation - 7th October 2019

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order is of the opinion that another road is available which provides alternative facilities for road traffic.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation and commencement

1. This Order may be cited as The Monaghan Road, Armagh (Abandonment) Order (Northern Ireland) 2019 and shall come into operation on 7th October 2019.

Application

- 2. The areas of road described in the Schedule are abandoned.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned areas of road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

Article 2

AREAS OF ROAD TO BE ABANDONED

Two areas of superseded road at the former Monaghan Road, Armagh consisting of—

- (a) an area of 1664 square metres of superseded road commencing at a point 85.5 metres south-west of the junction of Monaghan Road and Drumacanver Road and extending for a distance of 155.6 metres in a north-westerly direction, more particularly delineated and shown hatched and coloured red on map number IN1/18/691821; and
- (b) an area of 1656 square meters of superseded road commencing at a point 30.21 metres south of the junction of Monaghan Road and Drumacanver Road and extending for a distance of 177.7 metres in a north-easterly direction, more particularly delineated and shown hatched and coloured green on map number IN1/18/691821.

A copy of the map has been deposited at the Department's Headquarters, Room 301, Clarence Court, 10-18 Adelaide Street, Belfast and at DfI Roads and Rivers Southern Division, Marlborough House, Central Way, Craigavon.
