**The Parking Places (Disabled Persons' Vehicles) (Amendment
No. 4) Order (Northern Ireland) 2021**

Made - - - - - *9th June 2021*

Coming into operation *5th July 2021*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

One written objection has been received and duly considered and no other representations have been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2021 and shall come into operation on 5th July 2021.

“2922.	Aigburth Park, Belfast (north side) – from a point 62 metres south-west of its junction with Pim’s Avenue for a distance of 5.5 metres in a south-westerly direction.
2923.	Canada Street, Belfast (south-east side) – from a point 11 metres south-west of its junction with Richardson Street for a distance of 5.5 metres in a south-westerly direction.
2924.	Fortwilliam Crescent, Belfast (west side) – from a point 70 metres west of its junction with Shore Road for a distance of 5.5 metres in a north-westerly direction.
2925.	Parkmount Terrace, Belfast (west side in a lay-by) – from a point 11.5 metres north of its junction with Parkmount Place for a distance of 6 metres in a northerly direction.
2926.	Shore Road, Belfast (east-side in a lay-by) – from a point 64 metres south of its junction with York Park for a distance of 8.1 metres in a southerly direction.
2927.	Titania Street, Belfast (north-west side) – from a point 44 metres south-west of its junction with Cregagh Road for a distance of 5.5 metres in a south-westerly direction.
2928.	Allen Park, Donemana (south-east side) - from a point 178 metres south-east and then south-west of its junction with Longland Road for a distance of 6 metres in a south-westerly direction.
2929.	Beechfield Drive, Donaghadee (west side in a lay-by) – from a point 131 metres south-east of its junction with Cannyreagh Road for a distance of 2.4 metres in a south-easterly direction.
2930.	Union Street, Donaghadee (east side) – from a point 26 metres north-east of its junction with Moat Street for a distance of 6 metres in a north-easterly direction.
2931.	Trasna Park, Enniskillen (north-west side of parking area in front of No. 15 Unclassified No. 6306 Stretch 2) – from a point 19 metres south-west of its junction with Trasna Park, Unclassified No. 6306 Stretch 1 for a distance of 3 metres in a south-westerly direction.
2932.	Church Hill, Killyleagh (south-west side) - from a point 32 metres south-east of its junction with Cross Street for a distance of 5 metres in a south-easterly direction.
2933.	Grove Gardens, Killyleagh (west side) - from a point 109 metres west and then north of its junction with Grove Park for a distance of 2.4 metres in a north-westerly direction.
2934.	Highbury Avenue, Killyleagh (north-east side to the rear of No. 6 Highbury Walk) – from a point 131 metres south-east of its junction with Castle Gardens for a distance of 5.5 metres in a south-easterly direction.
2935.	Bellevue Avenue, Londonderry (south-east side) – from point 66 metres north-east of its junction with Ferguson Street for a distance of 6 metres in a north-easterly direction.
2936.	Emerson Street, Londonderry (north-east side) - from a point 36 metres south-east of its junction with Bonds Street for a distance of 6 metres in a south-easterly direction.
2937.	Mount Street, Londonderry (south-west side) – from a point 23 metres north-west of its junction with Rosemount Avenue for a distance of 6 metres in a north-westerly direction.
2938.	Shore Road, Millisle (west side) – from a point 24 metres north of its junction with Seaview Avenue for a distance of 6 metres in a northerly direction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2)(a).
