ROAD TRAFFIC

**The A85 Trunk Road (Inveraray Junction, Loch Awe)
(Temporary Prohibition of Specified Turns) Order 2018**

Made - - - - *1st February 2018*

Coming into force - - *11th February 2018*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A85 Trunk Road (Inveraray Junction, Loch Awe) (Temporary Prohibition of Specified Turns) Order 2018, comes into force on 11th February 2018 and ceases to have effect on 17th March 2018.

Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the schedule of this Order so as to make any turn specified in Part 2 of the schedule when a prohibition is identified as applying to that length of road by means of an appropriate traffic sign of the type described in item 7 (diagram 612 – no right turn for vehicular traffic) or item 8 (diagram 613 – no left turn for vehicular traffic) of the sign table in Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions 2016^(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the 1991 Act, schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54) (relevantly amended by S.I. 2001/1400). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle while being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the A85 Tyndrum - Oban Trunk Road from a point 100 metres or thereby southeast of the A819 Inveraray Junction north-westwards to a point 100 metres or thereby north-westwards of the A819 Inveraray Junction, a distance of 200 metres or thereby.

PART 2

SPECIFIED TURNS

1. All right turns from the south-eastbound A85 Tyndrum - Oban Trunk Road to the A819 Inveraray Road.
2. All right turns from the A819 Inveraray Road to the south-eastbound A85 Tyndrum - Oban Trunk Road.
3. All left turns from the north-westbound A85 Tyndrum - Oban Trunk Road to the A819 Inveraray Road.
4. All left turns from the A819 Inveraray Road to the north-westbound A85 Tyndrum - Oban Trunk Road.
