

## **Freedom of Information Act 2000 (FOIA)**

### **Decision notice**

**Date:** 29 January 2020

**Public Authority:** Greater Manchester Combined Authority

### **Decision (including any steps ordered)**

---

1. The complainant requested information from Greater Manchester Combined Authority (GMCA) about a computer system.
2. The Commissioner's decision is that GMCA has failed to complete its deliberations on the balance of the public interest within a reasonable time and has therefore breached section 17(3) of the FOIA.
3. The Commissioner requires GMCA to take the following step to ensure compliance with the legislation.
  - Having confirmed that information is held within the scope of the request: either disclose the requested information or issue a refusal notice in accordance with the requirements of section 17 of the FOIA.
4. GMCA must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

## Request and response

---

5. On 12 August 2019, the complainant wrote to GMCA and requested information in the following terms:

*"Please provide me with the following:*

*- all minutes from meetings with the chief constable and the mayor and/or deputy mayor about the roll-out of the iOps computer system, or any at which the subject was included on the list of business to be discussed*

*- all reports tabled to said meetings about iOps or the wider computer system transformation programme within which it sits."*

6. GMCA acknowledged the request on 12 August 2019.
7. On 11 September 2019, GMCA wrote to the complainant to explain that it held information relevant to the complainant's request, but that it would need to extend the time taken to complete its public interest test considerations in respect of an exemption under section 43 of the FOIA.

## Scope of the case

---

8. The complainant contacted the Commissioner on 27 November 2019 to complain about the delay in GMCA's consideration of the public interest test.
9. On 18 December 2019 the Commissioner wrote to GMCA, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 20 working days. To date, a substantive response has still not been provided.
10. The Commissioner has considered whether GMCA has complied with its obligations in relation to section 17 of the FOIA.

## Reasons for decision

---

11. Section 1(1) of the FOIA states that:

*"Any person making a request for information to a public authority is entitled –*

*(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and*

*(b) if that is the case, to have that information communicated to him."*

12. Section 10(1) of the FOIA states that a public authority must respond to a request promptly and "*not later than the twentieth working day following the date of receipt*".
13. Section 17(3) of the FOIA states that where a public authority is relying on a qualified exemption, it can have a "reasonable" extension of time to consider the public interest in maintaining the exemption or disclosing the information.
14. Although the FOIA does not define what constitutes a reasonable time, the Commissioner considers it reasonable to extend the time to provide a full response, including public interest considerations, by up to a further 20 working days. This means that the total time spent dealing with the request should not exceed 40 working days, unless there are exceptional circumstances. A public authority would need to fully justify any extension beyond 40 working days.
15. In this case, the total time taken by GMCA has exceeded 40 working days. The Commissioner does not consider there to be any exceptional circumstances and finds that, by failing to complete its deliberations on the public interest within a reasonable time frame, GMCA has not complied with section 17(3).
16. GMCA is now required to finalise its public interest considerations under section 17(3) of the FOIA and respond to the complainant.

## Right of appeal

---

17. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
