## ROAD TRAFFIC

## The A46 Trunk Road (Warwick to Coventry) (Temporary Prohibition of Traffic in Laybys) Order 2012

*Made - - - - 8th October 2012* 

Coming into force - - 15th October 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the A46 Trunk Road ("the A46") is satisfied that traffic on a length of that road, near Warwick and Stoneleigh in the County of Warwickshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

**1.** This Order may be cited as the A46 Trunk Road (Warwick to Coventry) (Temporary Prohibition of Traffic in Laybys) Order 2012 and shall come into force on 15th October 2012.

## **2.** In this Order:

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"the works period"

means the period starting at 18:00 hours on Monday 22nd October 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby adjacent to
  - i) the southbound carriageway of the A46 approximately 875 metres north of Stoneleigh Road overbridge near Stoneleigh; and
  - ii) the southbound carriageway of the A46 approximately 75 metres north of Wedgnock Lane overbridge near Warwick.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - **5.** The provisions of article 3 shall not apply to any vehicle-
    - (i) being used for police, fire brigade or ambulance purposes,
    - (ii) proceeding at the direction of, or with the permission of, a police constable, or
    - (iii) being used in connection with the said works.
