ROAD TRAFFIC

The A19 Trunk Road (Moor Farm Roundabout to Seaton Burn Interchange) (Temporary Prohibition of Traffic) (No. 2) Order 2012

Made - - - - - *25th October 2012*

Coming into force - - - - - *4th November 2012*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A19 Trunk Road, and connecting roads, in the District of North Tyneside and the County of Northumberland, is satisfied that traffic on that trunk road and some of those connecting roads should be prohibited because carriageway resurfacing works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

1. This Order may be cited as the A19 Trunk Road (Moor Farm Roundabout to Seaton Burn Interchange) (Temporary Prohibition of Traffic) (No. 2) Order 2012 and shall come into force on 4th November 2012.

2. In this Order; –

“the A19” means the A19 Trunk Road;

“the northbound carriageway” means the A19 northbound carriageway from its junction with the A189 Moor Farm Roundabout to its junction with Fisher Lane Roundabout, a distance of 3407 metres;

“a slip road” means the A19 northbound exit and entry slip roads at the A1171 Dudley Lane Interchange;

“the layby” means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition “carriageway” means any way (other than a cycle track) comprised in the A19 over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

“the first works period” means the period starting at 00:01 hours on Monday 5th November 2012 and ending when the said works have been completed;

“the second works period” means a period of 10 hours starting at 20:00 hours on Monday 5th November 2012 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5 no person shall, during the second works period, cause or permit any vehicle to enter or proceed in the northbound carriageway or a slip road.

4. Subject as mentioned in article 5 no person shall, during the first works period, cause or permit any vehicle to enter or wait in a layby situated adjacent to the A19 northbound carriageway approximately 1360 metres or 360 metres east of Fisher Lane Roundabout.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to any vehicle proceeding in the A19 to or from premises and property which is accessible for that vehicle from, and only from, that road.
