ROAD TRAFFIC

**The A6 and A5111 Trunk Roads (Thulston to Alvaston,
Derbyshire) (Temporary Prohibition of Traffic) Order 2014**

Made - - - - *17th November 2014*

Coming into force - - *24th November 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A6 Trunk Road (“the A6”), the A5111 (“the A5111”) and connecting roads, is satisfied that traffic on lengths of those roads and one of those connecting roads, between Thulston and Alvaston in the County of Derbyshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A6 and A5111 Trunk Roads (Thulston to Alvaston, Derbyshire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 24th November 2014.

2. In this Order:

“Thulston Roundabout” means the circulatory carriageway of the roundabout junction of the A6 and the B5010;

“the A6/A5111 Interchange” means the interchange of the A6 Alvaston Bypass and the A5111 Raynesway at Alvaston;

“the trunk road” means –

- a) the northbound carriageway of the A6 from Thulston Roundabout, to the junction with the A5111 at the A6/A5111 Interchange;
- b) the northbound carriageway of the A5111 from the junction with the A6, to the junction with the slip road leading from the A6/A5111 Interchange;
- c) the southbound carriageway of the A5111 from the junction with the slip road leading to the A6/A5111 Interchange, to the junction with the A6; and
- d) the southbound carriageway of the A6 from the junction with the A5111, to Thulston Roundabout;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1

“the slip road” means the slip road leading to the southbound carriageway of the A6 from the A6/A5111 interchange;

“the works period” means the period starting at 20.00 hours on Monday 1st December 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or the slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable;
- (c) being used for or in connection with the said works; or
- (d) proceeding to or from premises which are accessible from, and only from, the trunk road.
