Your Excellency,

29 June, 1976.

I have the honour to refer to the Seychelles Act 1976, and to state that it is the understanding of the Government of the United Kingdom of Great Britain and Northern Ireland that the Government of Seychelles are in agreement with the following provisions:—

- (i) all obligations and responsibilities of the Government of the United Kingdom of Great Britain and Northern Ireland which arise from any valid international instrument shall, as from the 29th of June 1976, be assumed by the Government of Seychelles insofar as such instruments may be held to have application to Seychelles;
- (ii) the rights and benefits heretofore enjoyed by the Government of the United Kingdom of Great Britain and Northern Ireland in virtue of the application of any such international instrument to Seychelles shall, as from the 29th of June 1976, be enjoyed by the Government of Seychelles.

I shall be grateful for your confirmation that the Government of Seychelles are in agreement with the provisions aforesaid and that this Note and your reply shall constitute an Agreement between the two Governments.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
