### **EXCHANGE OF NOTES**

# BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE UNITED STATES OF AMERICA CONCERNING THE ESTABLISHMENT ON ASCENSION ISLAND OF AN ADDITIONAL FACILITY TO BE OPERATED ON BEHALF OF THE UNITED STATES AIR FORCE

Excellency:

I have the honor to refer to the Agreement between the Government of the United States of America and the Government of the United Kingdom of Great Britain and Northern Ireland Concerning the Extension of the Bahamas Long Range Proving Ground by the Establishment of Additional Sites on Ascension Island, which was signed at Washington on the 25th of June, 1956, 1 as amended, in particular by the Exchange of Notes of 30 March 1973 concerning the expanded use of Ascension Island<sup>2</sup>.

The Government of the United States now desires to establish on Ascension Island on a plot of land known as Devils Ashpit a facility to be operated on behalf of the United States Air Force for a project involving ionospheric propagation observations to determine the extent of distortion of Very High Frequency/Ultra High Frequency (VHF/UHF) signals as they travel out of the atmosphere and back to earth.

I have the honor to propose that the provisions of the aforesaid Agreement as amended should apply to this facility, and that its installation, operation and maintenance should be regarded as authorized, notwithstanding paragraphs (1) and (3) of Article II and Article XIX of the Agreement. I further propose that the plot of land at Devils Ashpit on which the facility will be erected should be regarded as a site provided under the terms of Article IV of the Agreement. The exact topographical definition of the site and any easements shall be definitely established by arrangements between the United States authorities and the United Kingdom authorities, as shall precise details of when, and for how long, transmission shall occur. I confirm that the facility shall be operated taking full account of local concerns and so as to protect human health and the quality of the environment in and around Ascension Island.

I further have the honor to suggest that the Exchange of Notes Between the Government of the United States of America and the Government of the United Kingdom of Great Britain and Northern Ireland Concerning the Establishment on Ascension Island of a Facility to be Operated for the United States National Aeronautics and Space Administration, dated 7 July 1965<sup>3</sup>, as amended by an Exchange of Notes between our two Governments, dated 18 November 1980 and 19 December 1980<sup>4</sup>, be terminated from the date of your reply to this Note.
