The A494 Trunk Road (South West of Bryn Saith Marchog, Denbighshire) (Temporary Traffic Restrictions and Prohibitions) Order 2011

Made 7 June 2011

Coming into force

20 June 2011

The Welsh Ministers, being the traffic authority for the relevant length of the Dolgellau – South of Birkenhead Trunk Road (A494) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted and prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 20 June 2011. The title to this Order is The A494 Trunk Road (South West of Bryn Saith Marchog, Denbighshire) (Temporary Traffic Restrictions and Prohibitions) Order 2011.

2.—1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the A494 Dolgellau – South of Birkenhead Trunk Road, south-west of Bryn Saith Marchog in the County of Denbighshire, which extends from a point 250 metres west of Bryn Saith Marchog to a point 110 metres north of its junction with the unclassified road to Plasau Farm;

"works period" ("cyfnod y gwaith") means that period commencing at 00.01 hours on 20 June 2011 and ending when the temporary traffic signs are permanently removed.

- (2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- **3.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour, in the length of the trunk road.
- **4.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour, in the length of the trunk road.
- **5.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed along the length of the trunk road.
- **6.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road.
- 7. The provisions of articles 3, 4, 5, and 6 shall apply only during such times and to such extent as the application of the restrictions and prohibitions referred to therein are indicated by traffic signs.
- **8.** The maximum duration for this Order shall be 12 months
