**ROAD TRAFFIC, WALES**

The A55 Trunk Road (Junction 5  
(Treban) to Junction 7 (Cefn Du),  
Anglesey) (Temporary Prohibition  
of Vehicles, Cyclists & Pedestrians)  
Order 2022

*Made* 27 September 2022

*Coming into force* 3 October 2022

The Welsh Ministers, as traffic authority for the relevant length of the A55 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. The title of this Order is the A55 Trunk Road (Junction 5 (Treban) to Junction 7 (Cefn Du), Anglesey) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2022 and this Order comes into force on 3 October 2022.

**Interpretation**

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in

connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the A55 London to Holyhead trunk road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 3 October 2022 and ending when the temporary traffic signs for each period of works are removed.

### **Prohibitions**

3. No person may, during the works period, drive any vehicle on the lengths of the trunk road specified in the Schedule to this Order.

4. No person may, during the works period, ride any pedal cycle on the lengths of the trunk road specified in the Schedule to this Order.

5. No pedestrian may, during the works period, proceed on the lengths of the trunk road specified in the Schedule to this Order.

### **Application**

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

7. The maximum duration of this Order is 18 months.

### **SCHEDULE**

The length of the main A55 eastbound carriageway that extends from the nosing of the eastbound exit slip road at Junction 5 (Treban) to the nosing of the eastbound entry slip road at Junction 7 (Cefn Du), Anglesey.

The lengths of the eastbound entry slip road at Junction 5, eastbound exit and entry slip roads at Junction 6 and eastbound exit slip road at Junction 7.

The length of the main A55 westbound carriageway that extends from the nosing of the westbound exit slip road at Junction 7 (Cefn Du) to the nosing of the westbound entry slip road at Junction 5 (Treban), Anglesey.

The lengths of the westbound entry slip road at Junction 7, westbound exit and entry slip roads at Junction 6 and westbound exit slip road at Junction 5.
